

**INFORMATION NOTICE ON THE PROCESSING OF PERSONAL DATA  
PURSUANT TO ART. 13 EU 2016/679**

**Dondi S.p.a., 94/102 Viale Europa, Ospedalicchio Bastia Umbra (PG)**, wishes to inform you that Regulation (EU) 2016/679 of the European Parliament and of the Council of 27/04/2016 "*on the protection of natural persons with regard to the processing of personal data and on the free movement of such data*" (hereafter Regulation) - governs the processing of personal data and provides for a series of obligations for those who process information relating to third parties, in order to guarantee respect of their fundamental rights and freedoms, with particular reference to the confidentiality and protection of the personal data of the data subject.

Art. 4 point 2 of the Regulation defines "**Processing**: as any operation or set of operations which is performed on personal data or on sets of personal data, whether or not by automated means, such as collection, recording, organisation, structuring, storage, adaptation or alteration, retrieval, consultation, use, disclosure by transmission, dissemination or otherwise making available, alignment or combination, restriction, erasure or destruction";

Pursuant to art. 13 of the aforementioned Regulation we provide you with the following information:

**DATA CONTROLLER - pursuant to art. 13.1. a):**

**PURPOSES OF THE PROCESSING - pursuant to art. 13.1. c):**

- Sending newsletters and information on promotions, events and new products.

**LEGAL BASIS OF PROCESSING - pursuant to art. 13.1. c):**

- Consent to the processing.

**SCOPE OF DISSEMINATION - pursuant to art. 13.1.e)**

- The data collected will not be disclosed and disseminated. The communication to third parties, other than the Data Controller, by Data Processors external to the company structure, and by persons in charge of the processing identified and appointed for that reason includes communication to public bodies for the fulfilment of legal obligations, as well as, where necessary for the purposes indicated, to individuals and third-party companies, such as accounting and tax consultants, legal and industry consultants, debt collection companies and contractual consulting, third-party IT supply and assistance companies, involved in the correct and fair pursuit of the purposes described; also, auditing firms for the assigned auditing tasks. In any case, processing by third parties must be carried out fairly and in compliance with the provisions of the law in force.

**DURATION OF THE PROCESSING - pursuant to art. 13.2.a)**

- The Data Controller will process personal data for the time necessary to meet the aforementioned purposes.

**RIGHTS OF THE DATA SUBJECT - pursuant to art. 13.2.b), d)**


- We also inform you that, in relation to the aforementioned processing, in the cases permitted *by law*, you may request from the Controller access to and rectification or erasure of personal data or restriction of processing concerning you or object to processing, as well as the right to data portability. You may also lodge a formal complaint with the Data Protection Authority in accordance with the procedures indicated on the Authority's website at the address: <http://www.garanteprivacy.it/home/modulistica>
